# INFLUENCING POLICY

ENCATC provides feedback for an Ex-Post evaluation of the 2018 European Capitals of Culture (Leeuwarden and Valletta)



On 15 April, ENCATC delivered its <u>viewpoints</u> for the European Commission's call for feedback for an Ex-Post evaluation of the 2018 European Capitals of Culture (Leeuwarden and Valetta).

Starting from 11 April, the European Commission is accepting feedback for the evaluation that will cover the activities run by the two ECOC 2018. It aims at: analysing and understanding how the two ECOC 2018 contributed to the objectives of the ECOC Action; contributing to reinforcing the existing evidence base on the ability of the Action to produce cultural, social and economic impact; and drawing lessons from the implementation of the two ECOC 2018 that may be useful for future ECOC or cities wishing to bid for the ECOC title.

Feedback contributions may be published on the European Commission web page until 9 May and will be summarized and presented to the European Parliament and Council, with the aim of feeding into the legislative debate.

# ENCATC Cultural Happy Hour goes to the TEFAF in the Netherlands for the first time!

For the 42nd edition of the ENCATC Cultural Happy Hour, a limited number of guests had the privilege to receive a VIP entrance to the TEFAF, widely regarded as the world's preeminent organization of fine art, antiques, and design.

Held at the MAACH (Maastricht Center for arts, Culture, Conservation and Heritage), ENCATC's guests had a unique opportunity to observe one of the best galleries in the Tribal Art Section: Galerie Meyer and to talk to the owner, Mr. Anthony JP Meyer, who explained how his Gallery works and functions in Paris. He shared the essence of his Gallery's collection, the way all the objects become a part of it, as well as many stories and secrets about the essence of tribal arts and all the spirituality and rituals behind his collections.

We were also privileged to listen to one of the founders of the Morsink Icon Gallery: Mr. Simon Morsink. He gave us an overview about his Gallery which is located in the center of Amsterdam and renowned for its world-famous collections of extraordinary early Russian, Greek and Byzantine icons.

The visit also included a meeting with representatives of AXA-ART, an art insurance company as well as an art broker -AON. It was important to understand how the speed of innovations in the world of art insurance and brokerage is unprecedented and the European (Western) notions of art insurances don't necessarily apply everywhere else. Usually we are fascinated by the beauty of art works by conventional art fairs and in museums and rarely think about all these aspects immediately. It was a "wake up" call in order to start thinking about how and what are other issues at facing the art world!

In the framework of the European Year of Cultural Heritage, ENCATC calls on the need to define in advance a response to these great ongoing issues. A call to open up for a deeper reflection on the intersections between past- presentand future-making practices and legacies, for a contingent approach to cultural management and policy education, research and practice and for innovative research to build comprehensive forward-looking scenarios, knowledge, skills and competences to enable such a transition.

# MEET YOUR CONGRESS KEYNOTE!

On 27 September in Bucharest, Professor Jean-Louis Fabiani, member of the Institute for Advanced Study in Princeton, USA and Professor at the Central European University in Budapest, will join the ENCATC Congress.



He will share his critical reflection on the current cultural dynamics/ transformations and their implications in terms of heritagisation interconnections between past, present, and future making practices and legacies.

Jean-Louis Fabiani has been professor of Sociology at the Central European University in Budapest since 2008. Born in 1951 in Algiers (Algeria), he studied at the Ecole normale supérieure and received his PhD in 1980 from the EHESS (Paris). From 1980 to 1988 he was agrégérépétiteur then maître-assistant at the Department of Social Sciences at the Ecole normale supérieure. In 1988, he moved to the administration of culture, being appointed as Director of Cultural Affairs in Corsica. He went back to the academic world in 1991 when he joined EHESS, first in Marseilles, then in Paris in 2002. He is the author of eleven personal books. He was the chairman of the board of the Mediterranean Youth Orchestra from 1998 to 2014.

Hosted in the premises of the Romanian Ministry of Culture, this keynote will be followed by an engaging debate with experts and the international Congress participants.

How does the cross-sectoral approach affect professions and management in the cultural and creative sector? What are the best and worst practices?

# INTERVIEW WITH OUR PARTNER: THE NATIONAL INSTITUTE FOR CULTURAL RESEARCH AND TRAINING (INCFC)



This year, ENCATC member, INCFC is a partner of the 26th ENCATC Congress on Cultural Management and Policy. What does it mean for your institution to host this international gathering?

Since 2016, the National Conference of Cultural Managers organised each year by our Institute has received ENCATC's label. This was the first step, after entering ENCATC as a full member, in our partnership. During the last two conferences we invited 4 ENCATC members: Professor Milena Dragićević Šešić, Manuèle Debrinay-Rizos former ENCATC Vice-president) who teaches at Lyon 2 University, prof. Lluís Bonet (former ENCATC President - Facultat d'Economia i Empresa - University of Barcelona) and Camille Jutant, Director of the DPACI Master (Développement de projets artistiques et culturels internationaux) of ICOM (Lyon II University). Thus, ENCATC and its work were popularised among Romanian cultural managers and experts in cultural management and policies.

By organising this <u>26th Congress</u> "Beyond EYCH2018. What is the cultural horizon? <u>Opening up perspectives to face ongoing transformations</u>" from 26 to 29 September in Bucharest, it means acknowledging the importance of cultural management and policies within the need of having a national cultural strategy. Also, having European and international experts talking about cultural policies and the cultural heritage will offer an exchange of knowledge and will stress the importance of being part of a network such as ENCATC.



# Why are you excited to bring ENCATC members and our followers to Bucharest for the Congress?

This is the first time the ENCATC Congress is coming to Bucharest and Romania. It means not only promoting Romania and sharing our experience as an European country, but also a statement for the development of future cultural projects.

This year we celebrate 100 years since the foundation of our current modern state. For most cultural professionals this is not just a number to be celebrated. It is much more. It means celebrating the effort of cultural evolution and modernisation of the state.

I like to think that our joint effort to organise this event in Bucharest will be a beginning. Due to its partnerships, ENCATC is no longer just an European network but an international one, therefore the affinities and connections may be exponential.

It is very likely that a whole range of professional relationships will develop only because one day, two participants at an international conference in Bucharest, drink a coffee together...

# SAVE THE DATE!

What are the best practices in cultural governance? How do practices compare and differ across the globe? What will this mean for the future of cultural governance and cultural policy?

This Policy Debate aims to **improve quality and practice of cultural governance** across the globe. Academics, researchers, cultural managers and entrepreneurs, artists, policy makers, international, European and national civil servants, and students will gather for a one-day intensive discussion to **better understand the global picture of good practice in cultural governance**.

Predominantly, what we know at date is gathered from a narrow set of literature and understandings that is mainly western (from predictable locations, for example: UK, USA and Europe).

There is a **need to strengthen understanding of cultural governance in other corners of the world**.

This Policy Debate will be a unique opportunity for the participants to **learn about how arts and cultural organisations are managed outside in major cities around the globe** and thus to bring new ideas and management practices in their own institutions.

# "Cultural Heritage in Focus at the Bulgarian Presidency of the Council of the EU" ENCATC members sought for expertise

"*United we stand strong*" is the motto of the ongoing Bulgarian Presidency, and this explains why cultural heritage received a due attention in its programme.

Obviously, it is in good tuning with the 2018 European Year of Cultural Heritage, but there are other and more fundamental reasons for bringing heritage into the European public focus. It will not be an overstatement that the spirit of common European heritage and culture is evoked whenever the EU is facing geopolitical and economic challenges.

No doubt, the philosophy of European cultural heritage is one of the strongest possible antidotes against the growing Euroskepticism and different nationalisms and regionalisms flaring up here and there after the Brexit and the current refugee crisis in Europe. Therefore, the ambitious aim of the Bulgarian Presidency to highlight cultural heritage in the EU political agenda as one of the most important tools to foster a sense of belonging and community among European citizens, and to invigorate the unifying links between our societies, deserves admiration. This happened during the conference "*Cultural Heritage: For a More Sustainable Europe*" organised by the Ministry of Culture and the European Commission on 26-27 March 2018 in the historical city of Plovdiv, selected for European capital of culture 2019.

While the plenary sessions were devoted to more general issues such as "*The evolution of the consideration of heritage in the policies of European and international institutions*" (Bruno FaveU; "*Sharing Heritage, sharing our future in Europe - some reflections about the place of* 

cultural heritage" (Dr. Uwe Koch); "Why integrated and cross-sectorial?" (Terje Nypan); "European Cultural Heritage as a tool for public diplomacy" (Prof. Milena Dragisevic-Sesic); "Towards a European Action Plan for Cultural Heritage" (Erminia Sciacchitano, European Commission), indepth discussions took place in three thematic sessions: "Competences of the European Union in the field of cultural heritage"; "Mainstreaming of cultural heritage – levelling the playground for different EU policies", and "Participatory governance of cultural heritage – how to turn good European practices into a model of socially inclusive governance?" Among the important contributors to the discussion should be mentioned Pier Luigi Sacco (Italy) and Tzveta Andreeva (ECF).

ENCATC was well represented among the speakers including Thomas Knubben (Pädagogische Hochschule Ludwigsburg, Germany); Milena Dragisevic-Sesic (Faculty of Drama Arts, University of Arts Belgrade, Serbia), Svetlana Hristova (Department of Cultural Studies, Faculty of Arts, South-West University "Neofit Rilsky", Bulgaria); Claire Giraud-Labalte (ENCATC Ambassador on Heritage, France) and Dea Vidovic (Kultura Nova Foundation, Croatia).

The political acknowledgement of the high relevance of the conference was validated through the presence of key figures in the field of European cultural policies, such as Tibor Navracsics, the European Commissioner for Education, Culture, Youth and Sport; Michel Magnier, Director for Culture and Creativity, European Commission, Mircea Diaconu, Vice-Chairman of the CULT committee, European Parliament, Dr. Giuliana De Francesco, Vice Chair of the Steering Committee for Culture, Heritage and

Landscape (CDCPP), Council of Europe; cultural officers from broad spectrum of national administrations from different parts of Europe.

A special accompanying event was the European Heritage Label Award Ceremony, which took place in the evening of March 26 at the Cinema Theatre of Plovdiv.

Implicit attestation of the conference quality is the fact that it served as an idea-pool for the preparation of **Council conclusions on the need to bring cultural heritage to the fore across policies in the EU**, which will be adopted the next month in Brussels.

Another forthcoming EU Presidency event in support of the cultural heritage preservation and protection is the thematic conference "Illicit Trafficking of Cultural Goods" which will take place in the National Palace of Culture in Sofia, notably in the Day of Europe on 9 May.

# Innovation in cultural heritage research

The extraordinary context of this policy paper is the launch of the first European Year of Cultural Heritage in 2018. This policy paper attempts to assess the potentials and challenges of a shared European cultural heritage. Research on these complex challenges is to provide evidence and advice

towards better education, cultural, social and other policies at European, national and regional levels. A review gives the state-of-the-art of current EU-funded research on cultural heritage. Based on this mapping exercise interpreted in its wider scientific and policy context, the policy review makes suggestions to attain an appropriate European research framework after 2020, fitting both the current concept of cultural heritage and the corresponding cultural, societal, economic and ecological challenges.

For this ENCATC in Contact Interview we sat down with our member, Carmen Croitoru, Manager of the National Institute for Cultural Research and Training (INCFC). We wanted to learn more about the institute's motivations for joining ENCATC and what it is working on.

# What are your reasons to become an ENCATC member?

I became a member of this network after we set up and restructured the Institute driven by the desire to increase the international visibility of this unique structure in Romania. I was already following the network for 2-3 years and I was interested in exploring the rich European and international practice in cultural management training and learning. Many of its members were known for their professional and scientific work and I was amazed to discover that they were preoccupied by the same theoretical dilemmas that I myself had back in my professional activity. Thus the connection with many of them was natural and instantaneous.

Besides famous teachers and leaders in the field of cultural policies such as Milena Dragićević Šešić, I had the pleasure to discover and personally meet Lluís Bonet, Manuèle Debrinay-Rizos, and SO many other professionals. Some interesting projects came up easily after we got together. Thus Manuèle Debrinay-Rizos who teaches at the University of Lyon 2, a member of ENCATC, became one of the Institute's most important and close consultants. In 2017, we translated and published the



latest book signed by Lluís Bonet and Hector Schargorodsky – *La gestion de teatros: modelos y etrategias para equipamientos culturales.* The book was launched at the National Conference of Cultural Managers in November 2017 in Bucharest, being the first international translation of this work.

# How would you like to see ENCATC evolve in the future?

It's hard to predict how a network that has grown exponentially lately, will evolve.

I hope that it will manage to stay alive, fresh, open, and this can only be done through high quality members. I hope it does not become an "aristocratic"



organisation, as it has happened over time with other networks, placing more emphasis on form than on the content. And I also hope it will remain surprising and criticized and pretty far from being perfect, because these are long-lasting signs of life....

## Do you have any other projects you are working on that are interesting for ENCATC members and followers?

INCFC is by its nature focused on cultural statistics and the development of cultural management. Along with the ENCATC network, there are experts from similar institutions in the world, as well as independent experts such as COMPENDIUM, involved in various interdisciplinary projects.

The most important projects recently opened are the construction of the Satellite Account for Culture, the development of UNESCO indicators for Romania, a technical assistance partnership from the Department of Cultural Statistics of the French Ministry of Culture, the harmonisation of cultural strategies and policies with the EU agenda and the projects CDCPP (Steering Committee for Culture, Heritage and Landscape).

In the field of cultural management we are involved in developing curricula for art universities, and we take steps to several connected set up cultural specialisations such as: administrator, curator, producer and project developer for cultural projects, but also to train evaluators and assessors for cultural organisations. In short, there is countless need of different expertise which can become attractive for ENCATC members from all over the world.



Carmen Croitoru is associate professor at the National University of Theatre and Cinema since 2011 and has over 20 years of experience in cultural management. She is constantly preoccupied with developing cultural management in Romania and was involved in the legal requirements of this field (law for implementing management for cultural public organisations, and the legal status for the Cultural Manager as a profession).

She graduated the Academy of Theatre and Film of Bucharest and has a master's degree in Theatre Studies and a master's degree in Cultural Management, a PhD in Theatre Studies as well as an accreditation as trainer and assessor of cultural public institution managers.

Since 2014, she has been the General Manager of the <u>National Institute for Cultural</u> <u>Research and Training</u> and has established the basis for a National Conference for Cultural Management that has been in the running every year since.

She is a member of several international and national professional networks: ENCATC, Europeana, national representative member for the EU Commissions for Creative Sectors, member in the Board of Compendium Policies & Trends for Culture, founder of Professional Association for Romanian Cultural Managers, and a cofounder of the ECUMEST Association. # A UNESCO-ENCATC project identifies higher education programmes on Intangible Cultural Heritage in Europe

With a new vision of cultural heritage gaining prominence, **UNESCO** encourages integration of intangible cultural heritage (ICH) in training programmes for future decisionmakers and professionals in related fields, such as heritage studies, cultural management or sustainable development. However, despite international recognition of ICH and its critical importance for sustainable development, the theme has been largely neglected in relevant studies in almost all the world regions.

In this context, the UNESCO-ENCATC project "Learning on intangible heritage: building teachers' capacity for a sustainable future" aimed to revisit the training programmes of universities, as well as to strengthen their capacity building in ICH and, by doing that, help UNESCO raise awareness about the 2003 Convention and its purpose. This project was implemented by ENCATC UNESCO's Participation under Programme 2016-2017 and in 3Walks-Cultural partnership with Research, Training and Knowledge and Social Transfer. 3Walks, a member of ENCATC, was in charge of the scientific coordination of this project.

In the framework of this project, an extensive mapping of higher education programmes throughout Europe was carried out, identifying among those the programmes currently offering education on cultural heritage and ICH in all European countries, at the undergraduate, graduate and postgraduate level. A total of over 11,772 programmes were mapped in over 850 universities in 45 countries.

ICH programmes, subjects and content were mainly found across the following fields of study: museology, ethnology, tourism, archeology. history, art history, music, cultural management and language and literature studies, among others. This certainly remarks that ICH is an interdisciplinary object, and calls upon action for the development of higher education curricula in accordance to this interdisciplinarity.

As shown by the preliminary analysis of the large dataset resulting from the mapping, the number of programmes involving ICH in one way or another (having the term or a related one in the title, as a course or as content in non ICH-specific courses) is significantly high: 3,179 of the 11,772 programmes analysed in the 45 countries. However, it was found that the term "ICH" is barely used in European higher education programmes, which suggests there is a décalage between what UNESCO is proposing since 2003 (followed by state governments) and its reflection in education programmes. French universities are the only ones, across the analysed countries, using the term *patrimoine immatériel* in the titles of a few MA programmes, four of them more precisely.

It must be highlighted that the mapping was conducted of those programmes for which there was information available in one of these ten languages: Catalan, Dutch, English, French, Galician, German, Greek, Italian, Spanish and Portuguese. However. the programmes might be taught in many different languages, namely the official languages in the 45 mapped countries. Language and other methodological issues (such as the difficulty to access some information online) certainly limit the scope of this research. While acknowledging these limitations, it can be argued that the data do provide a significant, first approach to a dataset of programmes involving ICH across all European countries.

The complete report resulting from the mapping and the first analytical approach to the dataset will be released soon.

As complementary to the research work, a discussion event was also organised in the framework of this project. The Round table "Learning on intangible heritage: building teachers' capacity for a sustainable future" took place on 5 December, right after the Third Meeting of the Stakeholders' Committee for the European Year of Cultural Heritage 2018 (EYCH 2018) organised in Milan alongside the European Cultural Forum. The session counted with the participation of 28 people, including teaching faculty and representatives of different stakeholder groups, such as government officials, community heritage workers, heritage bearers, communities of practice and other stakeholders on topics related to ICH.

The speakers in the roundtable were: Sneska Quaedvlieg-Mihailovic, Europa Nostra Secretary General; Erminia Sciacchitano, Policy Officer -Culture - Heritage, Economy of Culture at the Directorate-General for Education and Culture of the European Commission: Helena Drobná, Programme Specialist at UNESCO/Culture Sector, and GiannaLia Cogliandro Bevens. ENCATC Secretary General. The floor was also opened for the audience to engage in the debate. They all reflected on the current situation of CH and ICH studies, and compared the current developments of these areas of knowledge to the processes cultural management education went through at the end of the gos', and cultural diplomacy and international cultural relations more recently.

Another outcome of the UNESCO-ENCATC project is a special issue of the <u>/encatcSCHOLAR</u>, designed as both a tool for sharing the results of this project and a learning resource. This special issue is conceived as a space for the exchange of approaches, ideas, concerns, teaching methodologies and tools. This special issue is primarily intended for instructors, lecturers, professors,



researchers and students in fields related to cultural heritage and cultural management more generally, at undergraduate or postgraduate level. It is also aimed at cultural managers, policymakers and those involved in the development of cultural or cultural education policies and/or programmes.

The special issue of the publication / encatcSCHOLAR, in preparation at the moment, will count with the participation of lecturers at some of the programmes on ICH identified through the mapping. They will share their experience focusing on specific issues such as the insertion of ICH in different disciplines, or the methods used to teach ICH-related contents.

In general terms, it may be argued that, as shown by this project in many different ways, while ICH is already integrated in some courses for students of heritage studies, there is a great need for strengthening this component in the teaching and curricula of universities focusing on other related topics, such as cultural management, cultural studies, arts management, or similar.

As an overall result of this project and its different outcomes, some recommendations are made for the further insertion of ICH in higher education curricula, which have to do with: sharing terminologies and rationales, envisaging the needs of the job market, sharing knowledge and practice, cross-disciplines pollination and influencing policies.

# NEW PUBLICATION: "Assessing Governance in the Context of Copyright Systems" - Second Edition

The present publication explores different ways of assessing governance in national copyright and related rights systems. The characteristics of processes for making and implementing decisions are an important aspect of the copyright system's operation. Complying to generally recognized good governance principles provides an ethical basis for governance and leads to



improved decision-making processes, helping public authorities to meet their legislative responsibilities and to achieve better efficiency in the management of public affairs.

The purpose of this document is to define good governance in the context of the copyright system, select and describe generally recognized good governance principles particularly applicable to the copyright system, and finally present a list of questions for assessing governance in public institutions and collective management organizations.

This publication is the second edition of a document first published in June 2017.

The assessment of governance can be regarded as a separate research area in the larger context of the copyright system's assessment.

# White Paper for Unlocking the Economic Potential of the Cultural and Creative Sectors in Romania

This White Paper aims at drawing a few guidelines, based on which specific interventions may be built in the future by each sector or domain. It is intended to gather together under the broader concept of Cultural and Creative Sectors the domains which are traditionally market-oriented and are therefore more likely to generate economic growth and other fields which, even if are less market-oriented, they play a more powerful social role (community cohesion and inclusion).

A White Paper marks the zero point of a process, of planned capitalization of the potential of the cultural and creative sectors (CCSs); in simpler words, the process of capitalizing on creativity as the most important resource of Romania. Although we have drafted this document by taking into consideration several levels of creativity, including those manifested in science and technology, we eventually decided to concentrate our attention in this White Paper on cultural manifestations in their broad sense.

This <u>White Paper for Unlocking the Economic Potential of</u> <u>the Cultural and Creative Sectors</u> has started as an initiative of the Prime Minister Office, in February 2016, following the Proposal to Unlock the Economic Potential of the Cultural and Creative Sectors in Romania.

The vision of this document reflects the approach of the European documents on this topic, according to which cultural and creative sectors "are characterized by an intrinsic dual value: they play a key role in the preservation and promotion of European cultural and linguistic diversity, strengthen the sense of belonging to the European and regional identity, contribute to transmitting knowledge and values, and safeguard the tangible and intangible European heritage for current and future generations. At the same time, they are a concrete tool for social cohesion, through their important contribution to the EU economy in terms of employment, investment, growth, and innovation and contribute significantly to Europe's competitiveness on a global scale."

In 2017 the Romanian Government, based on the White Paper, adopted a Memorandum for Enabling the Economic Potential of the Cultural and Creative Sectors in Romania.

# A UNESCO Chair in Cultural Policy and Cultural Diplomacy is established at Istanbul Bilgi University

In December 2017, UNESCO Paris accepted İstanbul Bilgi University's application for the establishment of a **"UNESCO Chair in Cultural Policy and Cultural Diplomacy"**. The relevant contract was signed between the University's Rectorate and UNESCO Director-General's Office on 21 March 2018. This is the first UNESCO Chair at BİLGİ, and the eleventh UNESCO Chair in Turkey.

The Chair has an interdisciplinary character and is expected to make a significant contribution to scientific work on culture (and art) management and policy at BİLGİ, in cooperation with the Undergraduate Program in Arts and Cultural Management, the Graduate Program in Cultural Management and the Cultural Policy and Management Research Center.

In this context, the Chair targets to: **contribute to existing projects** of local and international cultural institutions with a view to promoting international cooperation and dialogue in the field of culture; undertake efforts that will **support international cooperation** among stakeholders (especially the culture industries) and civil society, with a view to preserving and promoting the diversity of cultural expression; engage in **capacity-building and support existing international networks** with a view to promoting participatory culture policies; cooperate **with the UNESCO and with UNESCO chairs** engaged in similar activities; and promote the **dissemination and exchange of research in cultural policy and cultural diplomacy**.

The project for the establishment of the UNESCO Chair was led by **Assoc. Prof. Serhan Ada**, member of BİLGİ Faculty of Communication and Director of the Cultural Policy and Management Research Center. Stating that the establishment of the Chair marked a major academic achievement at the international level, Prof. Ada said: "*We believe that this new status will offer us unique opportunities for further improving our existing work on cultural policy at the national and international levels, and for contributing to academic work in cultural diplomacy, which is a relatively new field in Turkey*".

The application for establishing the UNESCO Chair was undertaken in cooperation with the Turkish Ministry of Foreign Affairs, the Turkish Publishers Association (YAY-BİR), the Turkish Music Producers Association (MÜYAP), İzmir Mediterranean Academy, Hildesheim University, and Belgrade University of Arts, a member of ENCATC.

# ENCATC members playing a major role in bridging the gap between teaching and professional development

ENCATC and five of its members are working together on a new European project funded by the European Commission's Erasmus+ programme. <u>CONNECT</u> is a Knowledge Alliance that promotes innovative cooperation between universities and enterprises in the cultural sector across Europe.

The purpose of CONNECT is to bridge the gap between teaching in the academic/higher education world and continuous professional development in the cultural sector for the promotion of best practices and a systemic growth of Audience Development.

The project consortium is composed of higher education institutions and private cultural organisations as well as public authority and a European network. It includes the following ENCATC members: the Fitzcarraldo Foundation (Italy); MeltingPro -Laboratorio per la Cultura (Italy); Adam Mickiewicz University in Poznań (Poland); Goldsmiths, University of London (UK); and The Audience

**Agency** (United Kingdom). ENCATC is also involved in the project as the leader for dissemination of project results. Other project partners in the consortium include: the University of Deusto, the Center for Kunst & Interkultur (Denmark); The City of Warsaw (Poland); and Asimétrica (Spain).

The project was selected for funding in autumn 2016. Over the course of 36 months, it is developing a new twintrack programme in audience development for students and practitioners working in arts management.

At date the project has complete its research phase of the needs of the selected target groups. The consortium is progressing on its design of the twin-track programme that will be tested by a transnational team of 54 researchers, teachers and trainers in five national hubs (Italy, Poland, Spain, UK and Denmark). The based programme is on multidisciplinary training modules mixing formal and informal learning methodologies and digital resources. Parallel running sessions will introduce audience development theory, practice and philosophy.

At the next project meeting in June in Rome, Italy, partners will meet for a train the trainers session who will

participate in the Mentoring Programme for Arts Mangers.

On 16 May 2018, the European Cultural Foundation celebrates a decade of change through culture. The laureates of <u>the 2018 Princess Margriet Award for Culture</u> are the **cultural centre Borderland** (PL) and multidisciplinary research agency **Forensic Architecture** (UK). The award will be presented at the Stadsschouwburg Amsterdam, in the Netherlands, and includes a sum of  $\in$  25.000 per laureate.

The **Borderland Foundation and Centre**. is one of the 2018 laureates for their work in Sejny – a small community in North-Eastern Poland close to the Lithuanian border. Revitalising lost memories and building bridges between the past and possible futures plays a central role in Borderland's work.

**Forensic Architecture** analyses matter to make sense of the ways complex realities are organised and transformed by conflict. This international multidisciplinary research group is drawing on architectural knowledge and using novel technological and aesthetic methods.

Prior to the festive award ceremony the first European Cultural Challenge will take place: A two-day advocacy retreat that brings together laureates, grantees, partners, researchers, foundations, media-makers and policy-makers to work on tangible cases that fuel positive change through culture. The European Cultural Challenge connects changemakers and contributes to rethinking and building Europe as inclusive and democratic an open, space. Outcomes of the event may vary from exploring cultural solutions to imagining campaigns and developing concrete advocacy proposals.

# Introductory speech by Ferdinand Richard, Chairman of the Roberto Cimetta Fund during the Final Conference of the Southmed CV programme "The impact of Culture in the Southern Mediterranean Region" Amman, 1-4/12/2017.

#### Ladies and Gentlemen,

In order to consider Culture as the vector of development in the Southern Mediterranean region, I would like to recall five evidences:

In our shared space, we are today facing an on-going attempt to re-nationalise Culture and Arts. Culture and Arts are now considered an ultimate tool for national sovereignties, a branding device for smart cities, a communication tool for mass-tourism. A growing consequence of this is the festivalisation of Culture, the reduction of critical narratives and experimentations, self-censorship... All in all, independent producers are more often considered as unsustainable sub-contractors surviving thanks to the accumulation of rapidly forgotten "projects". Our salvation depends on nothing else than re-inventing our "trajectories" in a shared political space, beyond the dictatorship of nationalisms.

We take good note that the growing political divide nowadays has its roots in the falsification of History, in any region of the world, here as well. Although it is never 100% achieved, Art as a witness for truth has an immense responsibility.

We ought to project ourselves in the future, refusing the dictatorship of immediacy, and look for long term multilevel solutions. The MENA region knows full well that sometimes quick solutions turn into long term problems.

We acknowledge that the notion of common good is wide, transversal, holistic and flexible. It is an on-going construction process. There is no dogma on what common goods are or should be. As indicated in their name, common goods belong to everybody and to no one person in particular.

We move in multiple and administratively overlapping spaces, which in many ways no longer respond to the classic neo-colonial approach of the so-called Euro-Mediterranean space. The Arab cultural world is far larger than the Mediterranean Sea, and it cannot be considered isolated from the entire Middle East. What is happening today in Saudi Arabia, Iran, Turkey, Kurdistan, etc... is evidence of this.

Therefore, an attempt to express some medium and long term tendencies in economy, in politics and in the humanistic sphere is necessary:

#### Economy:

Agile, flexible, transversal, multi-functional light-weight content industries will replace vertically-organised heavy-weight ones.

According to many specialists, content industries (multimedia, internet, communication, leisure, culture and online education) may become the first economic asset in the world in the next 50 years, following the decline of fossil fuels. Some petrol states have already begun to launch initiatives in this perspective. Global investment funds are already spending huge sums; for example, Providence Equity Fund published on their website, a plan to invest 50 billions dollars in global media, education and culture (they are already the owners of Warner). These global players are already attempting to rule our game.

However, this also means that funds dedicated to Culture will increase and thus, paradoxically, agile, hyper-active networks of lighter content industries, running on peer-topeer relationship models, will be able to strengthen their new markets since these will not be considered interesting enough financially by what I call "the monstrous militaryindustrial empires". These lighter content industries will still keep their leadership on R&D, on innovation, on creativity, but they have to quickly organise their independence from the big heavyweight industries. In this regard, skilled negotiators in the Cultural sector will be highly necessary.

Contrary to the heavyweight industries, these smaller, multi -lateral, instant, horizontal networks of lightweight industries will facilitate inter-cultural dialogue.

The nature of mass-consumption (of which mass-tourism is the most visible aspect in the Med area) and its requirement to constantly be at its maximum efficiency, drives it to separate individuals into different categories up to a point which becomes hard to stand for human beings. The generation gap is a direct consequence of marketing consumption, city planning is directly linked to gentrification, women still have a lot of difficulties to have their human rights respected, etc... Mass-consumption is not only a threat to the environment, it is also a direct threat to intercultural dialogue. More than ever culture, as a platform for dialogue is an utmost priority.

Soberness as a personal form of behaviour as well.

The notion of ethical capitalism, which is by the way directly placed at the intersection of religions and secularism, remains marginal when confronted to profit maximisation. In the current context of global negotiations on economy, ethical capitalism still remains an intellectual speculation, and the absence of ethics in economy has a direct effect on the religious question, including in the most violent theatres of conflict. Censorship is not only political, it is also produced by some forms of economy. Who today is the guardian of ethics, of freedom of expression, of freedom of creation? The legitimate desire of inter-cultural dialogue



forces us to re-consider the restrictive control imposed by wild ultra-liberalism.

#### Politics:

The influence of cultural (and cultual) zones is gradually replacing the national borders, for the best and for the worst. Trapped in a very old-fashioned "block-againstblock" strategy dating from former centuries, the traditional competition between nations is being replaced by the instrumentalization of cultural differences (very often disguised under the term "cultural diplomacy"), by a socalled "shock of civilisations" which is more and more successful, although it is nothing else than a new make-up on the face of nationalism. In MENA region, after the apparent decline of colonial powers, some new regional or religious heavyweights try to occupy the empty chair, become more aggressive, more radical, gain more influence, although the constant and never-ending pressure of the US, Russia and the EU is still there, under new forms. Do these regional powers consider intercultural dialogue as an essential tool for peace? Do they even consider peace as their number one objective? Or do they prefer their expansion?

No culture, no dialogue... No dialogue, no peace... No peace, no business... War is the business...

Asia shows a growing interest for Africa and the MENA region. The centre of the world has shifted, from the Mediterranean to the Atlantic, and now from the Atlantic to the Pacific. Interestingly enough, we Arabs, Europeans, Middle-easterners, do not know that we are collectively seen from China as a single coherent cultural entity, with a common heritage, a common, original religious frame, and somehow common genetics. Is this reciprocal? Do we show interest in the other regions of the world? If yes, what are we collectively interested in? Social models? Market development? The exotic? Spiritualism? Can we collectively address the rest of the world? Isn't the rest of the world expecting us?

Beyond the fascinating and on-going research of "Cultural Base", a joint programme led by the Universities of Barcelona and Glasgow, the remaining and long-lasting question is: Who is integrating who? Who is assimilating who? What level of hybridisation is compatible with Cultural Diversity?

#### The human factor:

Whatever happens, the Europe of the younger generations, including the ones of immigrant origin, will be based on and will affect the Europe/MENA region relationship. What we can witness today is not the withdrawal of the European dream, but the somehow painful, often anticipated beginnings of a positive transformation, which requires that every single individual living in Europe redefines his/her

position towards the rest of the world. This also includes the re-balancing of another north/south-periphery/centre unfair deal, the one internally affecting Europe, between its north and its south, which, by a domino effect, is also weakening the relationship between Europe and the MENA region. The future partners of the younger generations in MENA region are everywhere in Europe, not only in the capital cities.

Whether virtual or physical mobility, the peer-to-peer, transversal, universal approach does not comply with the notion of a one-way, no return ticket.

The "golden triangles" of Art and Culture (for example London/Amsterdam/Paris) are the geographical bases of the empire. They concentrate all the tools of the cultural power. They behave towards the creative youth of the peripheries as magnets. The brain drain effect is their worst consequence. It deprives local communities of the return on the expensive investment that has been made in the education and capacity building of their youth. It prevents the creative youth from participating in the development/ reconstruction of its own community, and, on a not-so-long term, it fuels an unfair imbalanced situation, which incidentally nourishes europhobia inside, and xenophobia outside.

Everywhere in the world this "golden triangles" syndrome is growing. It is also the fruit of modern global planning politics.

Local development is the condition for a fair international relationship, the individual is the engine of this development, with his/her cultural and intellectual assets. Mobility is first of all an affair of local development, and cannot be reduced to a small cohort of smart people living in airports. It concerns first of all your ability to share the benefits of your trip with your community when you go back home. I believe that the future of the world will be made of an organic network of multiple peripheries. Peripheries are the multiple sources of knowledge, since knowledge is not the priviledge of a few scientific centres wherever they may be, including in the Euro-MENA region.

As a conclusion, I would refer to article 1 of the Universal Declaration of Human Rights:

"All human beings are equal in dignity and in rights".

In my understanding, to be equal in dignity means that there cannot be any dominating Culture.
